Notice to Exhibitors:

The safety of the dogs is our primary concern. By entering this test, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with, and are able to perform all obstacles safely.

All dogs must be on leash or crated at all times except when in the ring or when in the designated agility warm-up area. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Test Committee, be asked to leave the Test site. In such case, no refund of any fees paid will be made. Bitches in season are not permitted in the test. The club will refund all but ten dollars of the entry fee for bitches unable to compete for that reason. The Test Secretary must receive written notification from a Veterinarian of such a claim for refund by letter (not email) after closing date of March 13th, 2010

Food and toys are not permitted in the course area, and handlers are not allowed to use whistles or other instruments or devices.

Exhibitors are responsible for being at the ring gate when it is their turn to run.

Exhibitors may wear shirts or insignia of their training group if they wish.

At the handler's option, the dog may wear a flat (buckle or quick release) collar without tags or other attachments. Choke collars, pinch collars, electric and dummy electric collars are prohibited.

Unsportsmanlike conduct, including rough handling or misconduct of any kind, will result in an excusal from the ring.

Eligibility: This test is open to all teacup dogs measuring 17 inches or less at the withers, over the age of 12 months except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance.

Your dog must be registered to participate in TDAA Test. There is a registration form included in this premium, or you can register the first day of the trial. Teacup Dogs Agility Association Rules can be obtained online in the form of a PDF file at www.k9tdaa.com

Volunteer signups will be taken at the test.

Exhibitors must clean up after their dogs at the hotel and test site, if caught not cleaning up you will be asked to leave without of refund for the remainder of the test.

FOOD: Lunch is available at the test for a nominal fee.

FEO (FOR EXHIBITION ONLY)

TDAA now offers FEO runs. They are open to any TDAA registered dog in any class. These are offered at the option of the local/host club. FEO dogs will run last at their jump heights. They may run on lead. FEO runs do not count toward TDAA titles. No treats or food allowed. FEO teams will have a maximum time of 1.5 times the SCT. FEO cannot repeat any obstacles, no training in the ring.

Move-Ups: Move-ups will be accepted for dogs earning a title at a test up to the closing date. Move up requests must be in writing but may be sent via email. Move ups will also be accepted if a dog completes a title during the running of this trial. In such case, the move up request must be made immediately upon posting of scores for the class in which the title was earned. Move-ups for pre-entries should be sent no later than March 22, 2010. Day of Test move-ups will be taken within each day

Awards: Ribbons will be awarded for 1st through 4th in each jump height of each class. Qualifying ribbons will be awarded to all dogs receiving a Qualifying Score. Dogs may receive placement ribbons without qualifying.

Warm-Ups: A warm up area consisting of an agility jump will be provided. Obstacle familiarization on TDAA equipment will be offered before the first class each day.

Games Descriptions (For more detailed descriptions, see The Clean Run Book of Agility Games, 2nd Edition by Bud Houston . The book is available at Clean Run website :

www.cleanrun.com or through www.dogagility.org

Copypcat p.42 - This is a dog's choice game. The handler can direct the dog through the performance of obstacles in the order of his own choosing, or the dog's choosing, as the case may be. Scored points, then time.

Go for Broke p.70 - This is a game played in a manner opposite to the traditional gambler's game. This game starts with a gamble, which, if successfully completed, allows the team to go on to point accumulation. Scored points, then time.

Las Vegas p.102 - The object of this game is to accumulate as many points in 60 seconds by running sequences of varying point value. To get points for the sequence, the dog must complete the sequence without fault. Scored points, then time

Minuet p.108 - The dog and handler have 50 seconds. Repeat the sequence as a continuous loop until the time expires. The judge may specify that the dog has to cross the finish line or go to the table to stop time after the whistle blows to end scoring. One point is scored for each completion of the loop. One decimal point is earned for each jump in an uncompleted loop when time expires. If a dog drops a bar, the handler must stop and reset the bar. If the dog goes off course, one point is lost.

By competing in this TDAA trial, you and this dog are eligible to enter this tournament. Additional information and the premium list will be available at www.k9tdaa.com later this year. We hope you will consider joining us for this fun event.

The following is a list of obstacles to be used at this test: A-frame 6'8"(width is 30")with slats, 8' foot dog walk without slats, Teeter 12" (width 11") without slats, Closed, collapsed tunnel 18", Open (pipe) tunnels 16", 36" table, Tire jump, weave poles, single and winged jumps.

All obstacles meet TDAA equipment size requirements.

Height Divisions

Owners are responsible for entering the proper height division. All dogs that do not have a permanent jump height card must be measured before judging begins. At the handler's option, dogs may be entered in a higher height division, but not in a division lower than their proper height division. Dogs that run in a height division lower than their proper division will be eliminated. To figure leg to shoulder ratio: Height from the elbow to the ground ÷ height at the withers = % (ratio). If that percentage is less than 50% and meets the height requirement then the dog can jump at the next lower height.

- 8" and under at the withers jumps 4"
- 12" and under at the withers jumps 8"
- 15" and under at the withers jumps 12"
- 17" and under at the withers jumps 16".

Dogs competing with either a body-type (long-backed, dwarfish legs/deep chested, or weight-to-height provision) exemption, veteran jump height exemption, or both exemptions, will be scored and placed with the height class they measure into.

Jump Height Exemptions

Special provisions are made for dogs that are long-backed, have a weight-to-height exemption, or who have dwarfish legs (see rules for complete description of height exemptions at: www.k9tdaa.com). A jump height exemption (next lower height) will also be granted to veteran dogs (dogs of at least 7 years of age).

Standard Class

Beginner Agility – All dogs shall be eligible for participation in this class. There shall be no grandfathering of titles from other organizations.

Intermediate Agility – Only dogs that have earned the Teacup Beginning Agile Dog (TBAD) shall be eligible for participation in this class.

Superior Agility – Only dogs that have earned the Teacup Intermediate Agile Dog (TIAD) shall be eligible for participation in this class.

Games Class

Games I – All dogs shall be eligible for participation in this class. There shall be no grandfathering of titles from other organizations.

Games II – Only dogs that have earned the Games I (TG1) shall be eligible for participation in this class.

Games III – Only dogs that have earned the Games II (TG2) or Games III (TG3) shall be eligible for participation in this class.

Entries close at 6:00 PM March 13th, 2010, after which time entries cannot be cancelled, altered, or substituted. Entries will not be accepted without fees. No entries will be accepted which require a signature for delivery. All entries must be submitted on official TDAA Agility Entry forms, one dog per entry form.

Photocopied entries without the TDAA agreement on the back or attached are NOT acceptable. Unsigned, incomplete or illegible entries are NOT acceptable and cannot be entered in the Test. Faxed entries and/or credit cards cannot be accepted. Returned checks do not constitute a valid entry fee.

The Test Secretary will add a \$25.00 service charge for any returned checks. Subsequent returned checks from the same exhibitor may result in their being put on a CASH ONLY basis. Entry Fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Test Committee.

No entry fee will be refunded if the test cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

Day of event entries will be accepted at an additional fee of \$2.50 per run/per day. Day of event entries must be given to the secretary no less than 30 minutes before the judge's first briefing.

TDAA Dog Registration Numbers may be applied for with the dog's entry or at the trial so that your dog. So that your dog can participate in this trial.

How the Fast Track Move-Up Works

Titles may be grandfathered from other organizations on a "Fast Track" basis. A dog with a higher title from another organization may move up on the same day to the next level of TDAA competition with a qualifying score. It is possible to move up from Beginner to Superior on the same day, if the dog qualifies first in Beginner, and then qualifies again in Intermediate. Likewise, it is possible to move up from Games I to Games III on the same day if the dog qualifies at each of the lower levels.

A qualifying score in the lower class is required to move up to the next higher class. The dog's owner must submit a copy of title certificates for the dog.

A dog moving up on the Fast Track will not be eligible for placement within the class that he/she received the qualifying score.
